2. If your application is complete and you qualify to vote either as a resident elector or non-resident property elector, a mail ballot package will, per your request, be mailed to you or made available for pick-up commencing on or about September 28.
3. You are responsible for ensuring that your completed ballot package is received by **8:00 pm on Saturday, October 17, 2026**. Completed mail ballot packages may be submitted to the Chief Election Officer by one of the following ways:
 1. Mail, using the postage paid envelope, to: Chief Election Officer, Langley City Hall, 20399 Douglas Crescent, Langley, BC V3A 4B3.
 2. Deliver in person to Langley City Hall, Administration Department (second floor), 20399 Douglas Crescent, Langley, during regular business hours, Monday to Friday 8:30 am to 4:30 pm.
 3. Deposit in the drop box located outside of Langley City Hall, on the north side, to the east of the entrance door nearest to the surface parking lot, at any time until 8:00 pm on General Voting Day.
 4. Deliver in person to the Chief Election Officer at one of following voting opportunities:

- Tuesday, October 6 (1:00 pm to 8:00 pm)
- Wednesday, October 7 (8:00 am to 8:00 pm)

General Voting Day at Timms Community Centre, 20399 Douglas Crescent on:

- Saturday, October 17 (8:00 am to 8:00 pm)

Mail Ballot Packages received after 8:00 pm on October 17, 2026 cannot be accepted.

Important: Once you request a mail ballot you may not vote in person at a later date.

To be eligible to vote in the election you must be:

- 18 years of age or older on general voting day; and
- a Canadian citizen; and
- a resident of BC for at least six months immediately before the day of registration; and
- a resident of Langley City; OR
- a registered owner of real property in Langley City for at least 30 days immediately before the day of registration; and
- if a non-resident property elector, not holding the property in trust for a corporation or any other trust; and
- not otherwise disqualified by law from voting.
