3. **PRESENTATION**

Tera Edell, Recreation Supervisor presented a PowerPoint highlighting some of our upcoming events, as well as some events that are still in the planning process.

4. **FOR DISCUSSION**

a) Douglas Park Pickleball Club mural request.

A written request was made from the Douglas Park Pickleball Club to have a mural painted on the south wall of the new washroom building at Douglas Park.

The committee discussed the request and the committee's desire to have an artist collective collaborate on the design, and that the artwork illustrate the history of the park, the diversity of park users, and events and activities that take place there. There is also a desire to consider a wrap that would cover the entire building, including the washroom doors.

ACTION: The Director of Recreation, Culture and Community Services will estimate costs and prepare a Call to Artists to be discussed at the next meeting.

b) Aquatic Feasibility Study update

The Director of Recreation, Culture and Community Services advised that the Aquatic Centre Feasibility Study has been completed and that many connections were made. Council has endorsed concept 2 – hybrid renewal. Invest Langley City is asking for feedback until May 1st through [Let's Chat Langley City](#).

c) Accessibility Survey and AccessAbility Week update.

The Director of Recreation, Culture and Community Services shared that the Accessibility Plan is in development with Happy Cities Consulting. The plan is expected to go before council on May 25th.

Staff are planning National Accessibility Week activities for the week of May 31-June 6. Sensory Kits will be unveiled that week that will provide facility users an opportunity to borrow the kits during programs, events, and facility usage. A list of events will be shared when complete.

d) Permanent Public Memorial for Those Affected by the Toxic Drug Crisis.

The following motion was made at the March 9, 2026, Regular Council Meeting:

THAT the delegation from the Langley Community Action Team regarding the Proposal for a Permanent Public Memorial for Those Affected by the Toxic Drug Crisis be received for information.

Mr. Snyder provided a PowerPoint presentation regarding their proposal for a permanent public memorial for Those Affected by the Toxic Drug Crisis and requested Council provide support in principle for a permanent public memorial, explore collaboration with Langley Township, assist with identifying a park location, and consider financial or in-kind support.

It was MOVED and SECONDED

THAT the presentation from the Langley Community Action Team regarding "Proposal for a Permanent Public Memorial for Those Affected by the Toxic Drug Crisis" be referred to staff for report back to Council regarding permanent memorial location options, exploration of collaboration with the Township of Langley to deliver this permanent public memorial, and potential financial or in-kind contributions.

- b) Langley City Film Festival. April 2-3, 2027. Information will be sent out in April 2026.
- c) Glover Road Gateway Sculpture. Ongoing. It was discussed that this will be discussed at the May meeting.
- d) Heritage Markers. Ongoing. Further discussion to take place in July 2026. Salt Lane, Federal Building, Michaud House, Grove of Trees Music School, Langley Central School.
- e) Heritage Buildings and Artifacts. Task Group is Ms. Maxwell, Ms. Martens, Ms. Magnusson and Councillor White. Ongoing.
- f) Skytrain Car Upcycle. Ongoing.

Mr. Palmer reported that the Volunteer Rail Car Sub-Committee, formally the Sky Train Upcycle Task Group, convened to review subsequent steps for the project, acknowledging that the City currently lacks sufficient resources to undertake all tasks required for procurement.
