## 3. FOR DISCUSSION

## a. <u>Indigenous Task Group introduction and feedback</u>

Ms. Reekie was introduced as a consultant to the Indigenous Task Group. A discussion on the direction and/or information the committee members would like to receive from the Task Group on accessibility and inclusion took place.

Committee members asked for guidance on how to take the correct steps to grow, learn and participate positively as some need help in knowing how to move forward.

Ms. Reekie mentioned that territory acknowledgments show recognition and respect, and while it is welcomed, we should consider structuring our land acknowledgment in order of the streams and the connection of the four nations. We could consider changing the order to Matsgui, Kwantlen, Katzie, and Semiahmoo First Nations.

Ms. Reekie explained that reconciliation is complicated and there is not a check box of steps to take. It is important to recognize that people are all in very different places of understanding. Working as a committee, it was suggested that members have a good history of indigenous peoples in this country; residential schools are just one part of that. Continuous learning of indigenous peoples will guide our principals to move us forward. It is also important to recognize that we are visitors unless we belong to one of the four nations. Our work should be done with that that understanding.

The Director of Recreation, Culture and Community Services reviewed the mandate of the committee and stated that these are the areas in which indigenous consultation and suggestions are needed to be included in our strategy. This includes:

- Employment
- Delivery of Service
- The Built Environment
- Information and Communications
- Transportation, and
- Procurement:

Ms. Edwards entered at 4:50pm.

Ms. Sugars suggested attending National Indigenous People's Day at Douglas Park to speak with Indigenous Peoples to gather thoughts and provide a condensed survey to gather feedback.

## b. May meeting

The May 1<sup>st</sup> meeting overlaps with the LMGA conference. The meeting will be moved to May 8<sup>th</sup>. Ms. Sugars will be unable to attend.

## c. 2025 Workplan

2025 Workplan was discussed and approved.

## Objective 1: Develop an Accessibility Strategy.

Scheduled to complete a draft strategy by October 2025 and then present to council in November 2025.

Ms. Sugar's discussed large accessible washrooms and will provide staff a contact to connect.

### Objective 2: Public Feedback

Create an email and written feedback mechanism.

#### Objective 3: Education.

Attend a variety of events throughout the year to help educate the public and garner feedback.

#### Objective 4: Advocacy

Task Group to review and report on accessible versus adaptable housing and suggest ways to increase the number of accessible housing.

Task Group to review and strategize on encouraging rentals to people with disabilities.

## Objective 5: Indigenous consultation

The committee to determine clear expectations and needs for the Task Group.

## Objective 6: Communication Strategy

Create a flyer that can be handed out at community events promoting accessibility in Langley City.
