### **3. DISCUSSION**

1. Sustainability Framework Presented by Dena Kae Beno and Keith Jones
  - 1.1. The Sustainability Framework for the City of Langley was presented to the Committee.
  - 1.2. The Committee discussed the level of detail in the framework, including the magnitude and complexity, and how to achieve the desired outcomes.
  - 1.3. The Consultant (Keith Jones) advised the Committee to focus on attainable achievements including focusing on what needs attention.
  - 1.4. The City will continue to work on the framework, and will report back to the Committee as they continue.
  
2. Bat Friendly Certification
  - 2.1. The City officially obtained the Bat Friendly Certification on October 7, 2024.
  - 2.2. The City was virtually presented the Bat Friendly Certification by BC Bats at the October 21, 2024 Regular Council Meeting.
  - 2.3. On October 28, 2024, during a bat presentation at Timms Library by Terri-Lou and Ron Trainor of the Langley Field Naturalists, the City accepted a certificate, with media coverage by the Langley Advance Times.
  - 2.4. The BC Bat Program has been presented at schools providing education.
  
3. Earth Day:
  - 3.1. Tentatively scheduled on April 26, 2025.
  - 3.2. The Committee discussed the positive and negative outcomes of the event in 2024, and which items can be revised in 2025.
  - 3.3. Various recycling items were discussed, including car seats, textiles, and inner tubes for bikes.
  - 3.4. The E-Bike drop off was favorable in 2024 and should be implemented at the 2025 event.
  - 3.5. Staff Liaison to contact Metro Vancouver about collecting car seats and if there is an opportunity to be subsidized. Staff Liaison to also confirm if Metro Vancouver will attend Earth Day.
  - 3.6. Staff Liaison to coordinate updating the Upcycling Poster for various events leading up to Earth Day.
  - 3.7. There was discussion surrounding the potential of having a public speaker, tutorial or live music at the amphitheater.
