3. FOR DISCUSSION

a. Langley City website accessibility feature update

The text to speech feature of the website was demonstrated. It was noted that the icon and font on the home page is small and difficult to see for those with vision impairments. It was also noted that the location of the icon in the bottom right corner is not where the eye is drawn and a location in the middle or side of the screen would be better.

ACTION: Staff will investigate what, if any, adjustments can be made and will report back.

b. Committee Terms of Reference

The Chair reviewed the ToR and highlighted the role and mandate of the committee.

c. Open House Survey Results

Committee members were asked to review the survey results and bring forward any questions at the next meeting.

d. BC Electric Kick Scooter Pilot Project update

It was reported that the Province of BC has renewed the pilot project, which started April 5, 2024, for a four-year term with new regulations. The City of Langley is not a participating community in the pilot program.

Mr. Bergen expressed disappointment that it will take that long to complete. He noted that without bylaws in place to protect residents and visitors around the use of micromobility devices; municipalities could be at risk for liability.

IT WAS MOVED AND SECONDED

THAT the Accessibility Advisory Committee recommends that council review and consider developing guidelines and bylaws on the use of micromobility devices for the protection and safety of the citizens of Langley City.

e. BCBC Illustrated Guide on Accessibility

Ms. Ettenberg commented that this is an important document to reference to understand the difference between adaptable and accessible.

ACTION: Staff to confirm who is responsible for ensuring accessibility in new builds, and answer if the City of Langley can go above and beyond the BC Building Code to require developers to implement enhanced accessibility.

f. 2024/2025 Work Plan discussion

Ms. Hilton reported that she will update the 2025 with items that need to be rolled over from 2024 and the committee can discuss any new initiatives.

SPARC BC is beginning the audit on Monday, February 10th.

4. SUBCOMMITTEE BREAK OUT SESSION

Breakout sessions are deferred to the next meeting as new committee members may be interested in joining a sub-committee.

An updated was provided on the Indigenous Consultation Committee which currently has three members. The first meeting is Feb 28th.
