Bylaw 3317 – 2026 Permissive Property Tax Exemption Bylaw

Pursuant to section 220 and 227 of the *Community Charter*, Langley City gives notice that City Council will consider adoption of Bylaw 3317, 2026 Permissive Property Tax Exemption Bylaw, which, if adopted, would exempt the properties listed below from property taxes for a term of one year, in 2026. Exemptions are reviewed annually to confirm eligibility.

This bylaw is scheduled for adoption at the Regular Council Meeting to be held on Monday, October 20, 2025, at 7pm in Council Chambers at Langley City Hall, 20399 Douglas Crescent.
